- Based on the student's preferences, term paper topics are allocated to students by January 31. We will try to give each participant the preferred subject.
- Students are required to confirm their participation by February 7.
- A withdrawal from the seminar will then still be possible for a period of two weeks, i.e. until February 21.
- If not all themes are assigned, a second round of registration for the remaining topics will be conducted by the end of March.
- All papers are due on May 24.
- The seminar takes place on June 4 and 5.

SEMINAR PAPER

The paper has to be submitted as a hard copy and as a pdf via e-mail to Annalisa Tassi (annalisa.tassi@fau.de).

The term paper should be about **12 DIN A4 pages** (formatted according to the chair specifications).

Please check the detailed guide for scientific work, which will help you in the preparation of your seminar work, before you start working on your seminar paper. **You will find the guide on our homepage.**

SEMINAR

The seminar will take place from Thursday, June 4, to Friday, June 5, at Burg Hoheneck, Ipsheim. If the number of participants is too small, the seminar will take place in the building of the department at Lange Gasse 20.

You shall prepare a **30-minute presentation** based on your paper. Each presentation is followed by a discussion round, where each student is encouraged to comment on the topic.

The grading is based on the quality of your term paper (50%), your presentation (30%) and your participation in the discussions during the seminar (20%).
